**100 days Campaign - “Saksham Niveshak” - July 28, 2025 to November 6, 2025,
Update Your KYC Details and Claim Your Unpaid/Unclaimed Dividends**

The Investor’s Education and Protection Fund Authority (IEPFA) & Ministry of Corporate Affairs (MCA) has via its intimation dated July 16, 2025, requested companies to launch a 100 days Campaign - “Saksham Niveshak”, to reach out to shareholders whose dividend remain unpaid/unclaimed.

In line with this initiative and even prior to the issuance of this intimation – C&S Electric Limited (the “Company”) had already taken various proactive steps to assist shareholders in claiming their unpaid/unclaimed dividends. Demonstrating its commitment to shareholder engagement and transparency, the Company has been dispatching electronic mails to shareholders, encouraging them to update their details and claim their entitlements.

These efforts will now be continuing under the umbrella of 100 days Campaign - “Saksham Niveshak”.

Purpose of 100 days Campaign - “Saksham Niveshak”:

To create awareness among shareholders to update their KYC & other details and claim any unpaid or unclaimed dividends before they get transferred to the Investor Education and Protection Fund (IEPF).

Action for Shareholders:

Shareholders are requested to update PAN; Nomination details, contact info [postal address, mobile number], Bank Account details, Specimen signature with the Company or the Registrar & Transfer Agent of the Company i.e. Alankit Assignments Limited, as Shareholder(s) whose folio(s) are not updated with aforesaid documents/details, their amounts of dividend will be withheld and only upon registering/updating the required details, they shall be eligible:

- To receive any payments including dividend in respect of such folios, only through electronic mode, effective from April 1, 2024.
- To lodge grievance or avail of any service request from the RTA only after furnishing aforesaid documents/ details.

Form SH-14: For cancellation of Nomination.

Shareholders holding shares in electronic form and those who have not claimed their dividend, can claim the same by updating / modifying their KYC and other details with their respective Depository Participants and intimating the updated details to the RTA of the Company.

The Member(s) of the Company are advised to claim unpaid/unclaimed dividend amounts, if any, in respect of final dividend for the financial year 2017-18 and thereafter, by sending a request to M/s Alankit Assignments Limited, RTA of the Company. Further, unpaid/unclaimed amount of dividend relating to interim dividend for the financial year 2017-18 and earlier dividends, have already been transferred by the Company to IEPF and accordingly, any claims in respect of such amounts are to be made directly to the IEPF Authority as per the Statutory provisions.

Shareholders are kindly requested to take note of the above instructions and act accordingly.
